### Reports from Department Heads -

A. Holloway –The financial Report for the month of March is in your folder. I spoke with representative from USDA they were going to contact Chad Griffin at Stillwater to start working on grant for the repair of Broad Street sewage lines. Stillwater has also started fill out the application for GEFA. We are planning on applying for a low interest loan to help pay for the repairs of the sewage line on Broad Street.

Mr. D. Davis – AIMS is in phase II of repairs on Broad Street they are hoping to finish p by end of the week. I am still working on the Policy and Procedure Manual and will get back with the Council at a later date. The City has thirty-six (36) businesses – All except 1 has paid for the 2019 Business License. I will be getting bids to repair the front of the Police Department.
