The City Council and Mayor of Lumpkin met for a regular meeting on Monday, January 7, 2019 at the above address with the following members present: Mayor Jimmy Babb, Mayor Pro-tem Barbara Cullefer, Council members - Flossie Brown, Billie Ann Mallory, & Darrel Wilson. Council members - Nikita Seay & Mitzi House were absent. The City Manager, David Davis was also present. City Clerk Anne Holloway was present to take minutes.

Mayor Jimmy Babb called the meeting to order at 6:05 p.m. The Mayor led the Pledge of Allegiance, which was followed by the roll call.

#### Public Appearances -

### Reports from Department Heads -

A. Holloway – The City Council folders are in order to follow the agenda outline. The financial Report for the month of December is in your folder. Georgia Safe Sidewalks will be here next week if the weather permits. I have completed & summited the LMIG grant paperwork on December 31, 2018. FEMA will be here on Jan. 15, 2019 for our first meeting in reference to Hurricane Michael. Mr. Davis & I have met with Mr. Chad Griffin in reference to the CDBG grant. The fire fighters cancer policy was renewed. There was no increase in premium or changes made to the policy. There is a gentleman, Mr. Kamlesh Bohra, would like to rent the old drug store from the city. He is looking to open a convenience store at the location. He stated that he would do all the repairs that needed to be done. He also wanted to know how much the rent would be for a year. B. Cullefer stated \$50.00 per month for one year. Mayor Babb –need to make a motion on the rent.

Building on Cotton Street rent will be \$50.00 per month for one year and the lessor would do all the repairs to the building

Mr. D. Davis – The Public Works team is working very hard to keep the City clean. I continually let them know that we appreciate them. They have started fixing driveways/potholes. We are going to need to get some cement to put in the different holes. I have done a survey of the different locations of the potholes. I also have a list of the signs that need to be replaced. We need to get some more signs to mark gas lines & sewage lines. The Sewage pond has a lot of different birds living on the site. We need to get it cleaned up because the City has to purchase a lot more chemicals to keep it clean. The Public works team will be attending training Tuesday in Albany, GA on Chemical Spills. I will have a couple of guys give a report at the next meeting. B. Cullefer – The City needs to see about getting the roof repaired on the old cleaners located on MLK Jr. Drive. B. Mallory – What's the plan? Mayor – It is ours – we don't want it to fall down.

Mr. Davis – We have received a few complaints in reference to dogs & cats. We have a complaint form in the City Hall that needs to be filled out. The form lists the complaint and tells how the issue is resolved. I have the team doing inventory at the City barn. They have found two very valuable pieces of equipment. I am trying to get quotes for gates at several different locations. We need to replace the one at the City barn & put one up at the sewage pond. The backhoe has been repaired and is running good. Mayor Babb – On College St. in the sharp curve there is street sign that needs to be moved to the end of the street.

#### New Business -

Mayor Babb – The Salon on the square will be closing next week. There have been a couple of lawyers that would like to rent some space on the square. Be prepared for the payment from Core Civic to come slow because of the Government shut down.

Mrs. Holloway – Flood Damage insurance needs to be adopted by the City & put on our building permits so that we will be eligible for grants.

Recreation Survey – We have received some of the surveys back. The surveys are in reference to the two City Parks. The Survey allows the City to see what our residents would like to have in the City parks. B. Cullefer – The School has just gotten an Art Grant maybe they can help with the tennis court. The County is trying to get the old high school building so that the EMS & Fire can be moved to that location. That will truly hurt our City. The County Commissioners will be meeting tomorrow at 4:30 in the Courtroom. It would be good if the City Council members could be present at the meeting. F. Brown – stated driving the school bus trying to cross over Hwy 27 is very hard. I had to sit there 10 minutes before I could cross over this afternoon.

## Council input -

- B. Mallory Can we do a tally based on the survey questions & give to the Council. F. Brown We need to get out as many as possible. B. Mallory Asked had the L.M.I.G. grant been completed & turned in? A. Holloway Yes, it was turned in on Dec. 31<sup>st</sup>.
- F. Brown I will try to get a few more survey completed. I received a phone call stating that they were very pleased with Mr. Davis & the workers.
- B. Cullefer Please let the Council know ahead of time when the events are going to be scheduled. I am very pleased with the town also.
- D. Wilson D. Davis keep up the good work. It has been brought to my attention that the Police Dept. is trying to implement a Pitt policy. The City doesn't need that liability. Mayor Babb We don't even allow high speed chases.

Mayor Babb - Would like a copy of the Building Permit fees at the upcoming workshop.
