Reports from Department Heads:

- 1. Clerk Anne Holloway The Deputy Clerk and I will be attending workshops on Feb. 2-4 and Feb. 25th -26th. Mr. Davis or I will be attending the Economic Development class on Feb. 27th in Americus, Ga.
- 2. I am currently working on getting reports ready for the 2019 Audit.
- 3. At our meeting on Tuesday, January 7th, the newly elected Council Members will be sworn in. Committee members will also be appointed.
- 4. Mr. Davis and the Public Workers will be attending training in Albany, Ga. on January 7th. Mr. Shephard will cover while they are at the workshop.
