Public Appearances:

Charlie Ponder – The old equipment (bull dozier) located on his property. The equipment has been parked on the property for several years. He would like to purchase the equipment from the City. Mayor Babb stated that the City needs to contact the City Attorney about selling the equipment.

Carlos T. – Address the serious problem of stray dogs in the City. 5-6 dogs tried to attack him and his wife many times. The City Ordinance was adopted in 2017 stated that if there was no Animal Control Officer that it would be the responsibility of the Police Chief.

Reports from Dept. Heads:

- 1. **Clerk A. Holloway** Mr. Davis gave the report: Still working on the CBDG grant paperwork. The City didn't receive the Immediate Threat and Danger, Program Grant. We discussed that the deposits made every Tuesday and Thursday of the week. Chris Wellborn from Municipal Gas will be reviewing City reports to prepare for an upcoming inspection.
- 2. City Manager David Davis Reported that the Post Office sewage has been repaired. The highway in front of the Post Office still needs to be repaired along with Surles Street. But due to all the rain, they have not been able to pave the spots. Georgia Power is trimming the trees in the right of way. They have the right to cut 15 feet back from the power lines. The County has helped us again. They hauled about five loads to Oak Street park. The County wants the City to put a fire hydrant at the Road Department. American Tank still waiting to clean the well on Trotman Road. Mark Majors had to come out and unstop the Auger Monster at the sewage plant. Mayor stated to talk to Wesley Brinson about purchasing a piece of equipment that will stop the items from clogging up the system.

3. Chief of Police – Ron Jackson- I spoke with City Attorney about the contract between the City of Lumpkin and Randolph County Sheriff Department for housing our prisoners. The department would like to purchase a tranquilizer gun to help in the capture of the stray dogs. There is a dog pound on Green Grove Road that can hold up to 9 dogs. There is a couple of repairs that will need doing, and it should be ready to open. Eufaula will help out with the stray dogs captured if they are under the age of two years old. The 16x12 tarp will need to have a couple of repairs along with the cable. I want to place a deer camera at the location to monitor the place. Here are the Ordinances that adopted in 2017 about the Animal Control. The City Clerk did not sign it at that time, so I would like to bring it back up and get it signed by City Clerk and Mayor. I want to ask that the City review the leasing contact so the City can lease three patrol cars from Barrow. Mayor stated that he would prefer to go with the five-year lease agreement.
