## New Business: Personnel

Mayor- What are we going to talk about? Friday, I was advised that we were going to talk about leaf and limbs. Then Monday I called the City and was informed it about Personnel. Mr. Davis what did she tell you? Meeting of the minds. B. Mallory – stated that I did not speak to Mr. Davis on Friday, but one day last week and I told him that I wanted to call a call meeting to discuss personnel, expectations, a meeting of the mind. Then, I asked Mr. Davis did I not say that to you and he replied that's what you said. B. Mallory – I understand perfectly – that is how miscommunication - we have been doing that quite often.

B. Mallory – I would like to go into an executive session to discuss personnel. Mayor – Let me read you the Sunshine Law:

Councilmembers may close the portion of the meeting during which members are deliberating or hiring, appointing, compensating, discipline, or discussing an employee. However, any portion of a meeting during which the Council receives evidence or hear arguments involving personnel matter must be open. Mayor Babb – That means we need to discuss whatever we have to discuss then go into executive session. B. Mallory – You say that we need to discuss whatever we are going to discuss? Mayor Babb – Yes, Ma'am. M. House – Even if it contains to something – I don't know; I just know we have always gone into executive session. B. Mallory – Yes. Mayor Babb – According to Ms. Cullefer, following the Sunshine Law, we have been doing it wrong. B. Cullefer – We are supposed to be like the judge and jury. You hear all the evidence open. Then you go into an executive session to discuss what's going to be done about the evidence. M. House – I thought went executive. B. Cullefer – According to the Sunshine Law, you don't. Ms. Brown and I got it in class. F. Brown – We did get that in class, but we have never followed it. B. Mallory – I was about to say – When did you get that in

class? Have we done it differently since you have been in class? We have not done it that way since you have gotten it; we have done it the other way. So why change it tonight? B. Cullefer – Well, I have said before - in the past. B. Mallory – But it's never been done.
