Carlos Tejeda — Yard upkeep. Mr. Tejeda was not present but wanted the council to be aware of the unkept yards in the city and that the residents should be held responsible for keeping the yards groomed or issued a fine.

Reports from Dept. Heads:

Clerk — A. Holloway provided the council with an attached update sheet. She asked the council how long she wanted to have qualified. The council stated that it would only take three days to qualify. The clerk informed the council that there was a memo about House Bill 189, Stewart Co Elementary Charter Program, and Financial Management programs she would like to attend. She also informed the council that the city has been losing money on providing gas for the CCA. The mayor stated that they should be paying more than residentials. The council asked that I look into the prices and contact the city attorney. The clerk informed the council all the January reconciliations for all the bank accounts were in their folder. They had also been emailed to them.
