Chief of Police – M. Holloway's 911 report was in their folders. I assist in repairing the water leaks, and the city needs to do something about the company that keeps destroying the city water lines and sewage lines. The leaks on Green Grove and Westwood Hills were their fault.

The council will keep the training/meals travel in their budget.


